## **Update from iPass Support & Tech Services**

What we are doing to keep iPass accessible and running as fast as possible:

 We recently updated our 24-hour monitoring system from Nigios to NodePing and now are seeing great improvement in the ability to monitor every aspect of the iPass servers. We have made many adjustments to servers and to iPass to reduce the number of alarms we see and have seen a drop in downtime due to CPU usage, Disk Size, and Memory issues.

### **Reasons for recent iPass Slowness:**

#### Reported Comcast issue

This past Monday Comcast had a nationwide issue. Our Hosted Facilities all have connections to Comcast to run certain aspects of the facility. The issue that Comcast reported yesterday has been resolved and we are no longer seeing the issues we had Monday.

### Disk Space

We are adjusting the Old Reports Storage and have moved it to another server. We have started to remove old reports that are not set to "SAVED" and that are older than a year old.

The monitoring system is finding some server logs have grown large and we are actively identifying the causes and removing them so sites do not experience disk space issues.

### CPU Usage

We have found that the SIF processors have been tying up the iPass data tables for too long as it gathers the SIF Data objects to send them out. This is showing a spike in CPU usage. We are making adjustments to sites to alleviate this issue.

# **Upcoming Patch Release**

We are planning to put an update out to iPass sites this week. The patch will include updates for: Discipline Consequences, Publishing, Call List, Site Performance, Homeless & Foster Care, SIF, Email Class, Compensation Assignment, and iParent. ### **Tips for Districts Reporting EPIMS via SIF**

**EPIMS WA07 Job Classification** – SIF EPIMS requires instructional staff have a Career record for each WA07 Job Classification reported in the Work Assignments. This means that teachers who are scheduled to co-teach a class (reported as 2306 Co-Teacher) or provide supportive content instruction in the classroom alongside a primary teacher (reported as 2310 Teacher – Support Content Instruction) require a Career record with a Job Type = Co-Teacher and/or Job Type = Teacher – Support Content added.

The MA DOE EPIMS screen's WA07 Job Classification selection field will list only the Career Record Job Types associated with the staff member. For example, a teacher with a Career Record Job Type of "Teacher" only will display only "Teacher" as an option in the WA07 Job Classification field. To have Co-Teacher as an option there must be an additional Career Record with Job Type = Co-Teacher.

**REMINDER:** SIF EPIMS requires one, and only one, assignment/career be documented as "Primary." All staff members with multiple active career records must have "Is Main Job" checked off for their primary career record only. If a staff member splits their time evenly between assignments, only one of the assignments/careers should be selected as "Is Main Job." If a staff member has only one career record it will transmit automatically as the primary assignment.

**Work Assignment FTEs** – With SIF EPIMS you no longer adjust the FTEs on the Work Assignment records. The DESE will find all the work assignments by Job Classification (i.e. Job Type = Co-Teacher), find the Career Record with that Job Type, and use the Career FTE (i.e. Co-Teacher .20 FTE) to calculate the FTE for each Work Assignment.

**IMPORTANT NOTE:** With SIF Transmission there is no way to exclude Work Assignments set to FTE = 0. Non-reportable Work Assignments need to be set up using a non-reportable Course Type or a staff member who is not reported to the DOE.

**SIF Job Type** – This additional SIF field can be found in the staff member's Career record. This must be filled in with the appropriate code. Refer to iPass Help > SIF > <u>SIF</u> <u>Job Types</u> for recommendations. This field is available for update on the Career Batch Entry screen.

**Teaching Assignment Code** – The Work Assignment requires a (SIF) Teaching Assignment Code field be filled in. This field is in addition to the WA08 Other Teaching Assignment Code. This field is available for update on the Edit EPIMS Work Assignment screen.

A. Teachers can use the Assignment Grade Report or Save to Excel feature to save a copy of their Gradebook/Rankbook assignment grades for safe keeping and record keeping. This gives a teacher a backup copy of the assignment grades they have entered should they need it. It is recommended that teachers create a copy at the time they submit grades (i.e. Progress Report mid-term grades and Report Card term grades), but can be done as frequently as desired (i.e. after entering grades for an assignment or group of assignments).
