Support Announcements

Important Update: 2310 Support Content Teacher

The Support Team worked with the DESE to finalize the changes needed to meet the new requirements to report via SIF transmission 2310 Support Content Teachers with no scheduled courses. Our previous attempts to automate the Subject Area Course

Code with "All Subjects 99999" and "Grade Level 99" for all of these records generated validation errors for Support Content Teachers in Prior-to-Secondary schools. Our latest update will now send the WA08 (Other Teaching Assignment Code), WA09 (Grade Level), and WA10 (Subject Area Course Code) selected in the Non-Course Work Assignment.

Patch Release: A patch release with updated code to send 2310 Support Content Teacher Staff Assignments with NO COURSES with the above change went out last night. Check your site's Login screen to make sure it's now showing Version: 7.0.20180604_sync.

<u>Action Required</u>: To update data at the DOE: DELETE SIF Temp Table to clear the StaffAssignment Object and SEND updated EPIMS data. Use either SIF Reporting > EPIMS to send all EPIMS objects by School and/or by MEPID or use Send SIF Objects to send StaffAssignment Objects for the entire district.

Note: Districts that reported 2310 Support Content Teachers with no scheduled course in October SIF EPIMS as an "Instructional Coach" or "Tutor" can change the SIF Job Type to the new 2310 Support Content Teacher NO COURSE one. There is no need to end the Career, just update the SIF Job Type.

iPass Releases & Updates

Recent Patch Release – 7.0.20180604_sync

A patch release went out on June 5, 2018 (v. 7.0.20180604_sync). The patch included updates for: Gradebook viewing of Future Schedules, 2310 Support Content Teacher with No Courses (Action Required), and Publishing Dashboard.

iPass Tips & Tricks

Reporting SSDR via SIF

The DOE is expecting districts to report their SSDR (School Safety and Discipline Report) via SIF Transmission. We recommend that you begin looking at your errors now and work on clearing them before the school administrators responsible for discipline are gone for the summer.

SSDR Error Codes

• Error: SSDR7040 – There are more offending student SASIDs than are counted in Offending student count: There are more SASIDS listed reported being disciplined than were reported in the incident report.

Check the Offender DOE Fields "Offender Type" selection is correct and reflects the type of offender reported in the incident record (ie. Student/Staff). You will get this error if you select Offender Type = Staff for a student offense record.

• Error: SSDR2025 – Offense code 1 invalid: The first offense code must be one of the allowed values listed in Table 1 (see appendix).

If you have an OT1 error due to a null value and your SIF Mapping is set up for the Offense code, check the Offender DOE fields "Offender Related To" selection. Check to make sure you have not selected a code that has been discontinued. Refer to iPass Helpf for <u>Code Mapping Recommendations</u>.

Check Offense Count

Check the DOE Security Portal > SSDR Offense Summary Report by District. The Total Offenses should = the DOE Security Portal > SIF Progress Report Object Count for the DisciplineIncident Objects, which should also = the number of Offenses in the iPass MA Discipline export flat file.

iPass FAQs

- Q. *MA Districts:* How do I reset the staff attendance values in iPass for Endof-Year EPIMS Report?
- Districts that use iStaff for Attendance will need to clear out the October values on the Batch Data Entry screen. Districts that don't use iStaff for Attendance will need to import the EOY values for Staff Days in Attendance (SR36) and Days Expected (SR37). <u>Click here for details</u>.
- Q. *MA Districts:* Why won't the SR37 Staff Expected Days of Attendance show correct values for EOY EPIMS report on the Batch Data Entry screen?
- A. For October EPIMS you may have adjusted the Days Expected values for the different employee contract groups. These need to be updated to the EOY values. <u>Click here for details</u>.

Q. *MA SIF Districts:* What is causing the SIF SIMS error of "Graduate percentage too low"?

- **A.** This error will appear in the SIF SIMS error reports until the seniors are graduated with a "Graduated" withdrawal record.
- Q. How do you import/export data between iPass and TeachPoint?
- A. There is a TeachPoint Export that allows you to export fields from iPass to import into TeachPoint. In addition, Staff Data Import can be used to import evaluation data (2-digit Rating codes) required for MA EPIMS state reporting. Refer to iPass Help > DOE ID Manager > Help > EPIMS (MA) > How do you import/export data between iPass and TeachPoint for more information.

NOTE: Staff Data Import requires the import file contain 6 required fields for matching staff and the data must match iPass <u>exactly</u>: First Name, Middle Name, Last Name, Employee ID, Gender, and Date of Birth.
