Updates

SCS Errors

9510 - Course Enrollment status and course letters mark not valid for course numeric mark

9520 - Course enrolment status not valid for course numeric mark

Here are some reasons for having the following errors.

1. The procedure for dropping a course was not done properly. Add the course, Adjust the Terms for that student and Drop the course again.
2. There are duplicate Student Section Marks records. Check the DOE portal using SCS Transmission Reports> Student Level Course Data. Search by SASID and see if there are duplicates. Ask the Doe to delete your Student Section Marks, Clear the SIF Table Student Section Marks and resend Student Section Marks.

3. Final Grades were not entered. Enter the Final Grades and send the Student Section Marks Object.

Scheduling for Covid-19 Start of 2020-2021 School year Things to keep in mind...

- Try not to change your schedule for the start of next year just to meet the Covid-19 Compliance. You may have to go into that old schedule at some point in the fall. Changing back and forth between schedules could complicate SCS Reporting.
- There are some ways you can use Teams to divide your student numbers into cohorts
- You can use Specialist Teachers (Art, Music, Computer, PE) to split classroom numbers up to reduce class size.
- You can save your current 2020-2021 Schedule with MSB and then try adding the teams to see how the schedule plays out. Then save that schedule too. This way you have two options at the start of the year.
- **IMPORTANT** Consider having a call with Laura Patton to go over options. This will help you avoid making a mistake or doing work that may not be needed.
