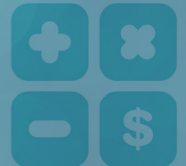

## SIF 2.7 Roll Out

- iPass is going live in production with SIF 2.7
- We will implement SIF 2.7 with a few districts first to work out an bugs in the updates or common errors in SIF reporting
- With success of these implementations we will move forward with a controlled Roll Out as fast as we can



# What will be in the SIF 2.7 Roll Out

- The SIF 2.7 agent
- Updates to a new version number
- Run scripts to add new fields
- Add new field codes
- Mapping tables as needed
- Defaulting codes as needed
- We will push all the data objects to the DOE
- Then you will be able to check your SIF reports
- The DOE will pull every night the objects for Attendance and Special education



## What to expect if you are not on SIF

- A patch will be going out next week to everyone SIF and Legacy. This patch will:
- Add the new fields and codes for DOE030 in SIMS and EPIMS SR38
- Add the new fields to the Legacy SIMS and EPIMS Export Files

# Other SIMS Changes

- DOE012 description of value 05 changed from “permanently excluded” to “expelled”
- DOE019 Low Income  
Districts can choose to report a student’s free or reduced lunch status, or they can report the default value 00 for all students
- DOE025 Added notes about Coding of Foreign Exchange Students who are ELL:
- DOE021 updated for PK and SP (has to equal 00)

00	No
01	Yes



# EPIMS Codes Changes SR09

## SR09 Employment Status at Time of Data Collection

### Acceptable Values/Code Description:

- 01 = Working – District Employee
- 02 = On Paid Leave
- 03 = On Unpaid Leave
- 04 = Exited
- **05 = Working – Non-District Employee**





# EPIMS Codes Changes SR34

## SR34 Impact on Student Learning Growth and Achievement Rating

### Acceptable values:

- **00 = Did Not Collect Data**
- 01 = Low Impact Rating
- 02 = Moderate Impact Rating
- 03 = High Impact Rating
- **04 = Year 1 of Data Collection - no rating determined**
- **05 = Year 2 of Data Collection - no rating determined**



# EPIMS Codes Changes WA17

## WA17 Term Status at Time of Data Collection

### Acceptable values:

- 01 = Active Term
- 02 = Inactive Term
- **03 = Active Term, Inactive Assignment**



# What To Do To Prepare

## SIMS

- Set the DOE Parameter screen to have 10/01/2015
- Run SIMS Exports at each school and look for blanks check enrollment numbers
- Check Report to DOE

## SCS

- Check Curriculum levels
- Subject Area Course Codes
- Run SIMS 13 exports for each school and look for blanks

## EPIMS

- Set the iStaff Configuration Screen to have “as of date” set to 10/01/2015
- Make the Export with Recalculate FTE: and Reset Term Codes: set to Yes
- Check for Report to DOE
- Start checking the Data

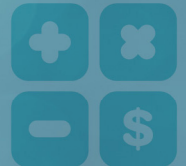


# Who Wants To Volunteer
