Important New Process: Updating DOE011, DOE012, and DOE013 Codes

Updating Enrollment Records – The September 28 patch release includes a new Warning message when end users try to change the DOE011 (Reason for Reporting), DOE012 (Enrollment Status), or DOE013 (Reason for Enrollment) fields without exiting or enrolling the student. This feature is designed to prevent original enrollment records from being deleted in error and to ensure the StudentSchoolEnrollment Object is sent accurately to the DESE via SIF.

To protect the integrity of student enrollment records and to ensure the update to a student's StudentSchoolEnrollment Object is transmitted to the DESE, iPass no longer lets the user update the DOE011 (Reason for Reporting), DOE012 (Enrollment Status), or DOE013 (Reason for Enrollment) fields within an existing enrollment record. If these codes must be changed, the proper procedure now is to delete the incorrect enrollment record and create a new one. For example, a student was enrolled at the start of the school year but is then determined to be a summer withdrawal. The enrollment record for the new school year should be deleted and a new withdrawal record created with the correct enrollment codes.

iPASS FAQs

Q. How do I reset the staff attendance values in iPass for the October 1 EPIMS Report?

- A. If you use iStaff for Attendance: The values submitted for staff reported in the EOY EPIMS are there until you clear them out. If you do not use iStaff Attendance: You will need to import the October 1 values for the Staff Days in Attendance (SR36) and Days Expected (SR37). [Click here for detailed instructions.](#)
