iPass Releases & Updates

Patch Release – 7.0.20170511_sync

A patch release that went out May 11 included minor enhancements, updates and corrections. SSDR Report (MA) – Important Updates

The May 11 patch release included the following updates related to SIF SSDR transmission:

Reporting Emergency Removal with Extra Suspension Days

The Massachusetts DOE discontinued the Extra Suspension Days field that was previously used to report extra suspension days after an emergency removal. To accommodate this change, the extra suspensions days beyond the removal now will be reported as an additional consequence in the incident record.

If the first Consequence entered into the Discipline Incident record is a Removal Consequence code linked to Disciplinary Action Taken State Code of 5 or 6 (Removed by school personnel to an alternative setting or Emergency Removal), iPass will send the second Consequence to the DOE to report the extra days. <u>Click here for more detail</u>.

Reporting Victims Without Identifying Name

Certain Report to DOE Offense Types codes require a victim be reported (Codes 3, 4, 5, 6, 8, 9, 12, 13, and 17). SIF SSDR transmission requires a victim be entered into the Discipline Incident records, not just a number entered into the Number of Victims field. To accommodate districts that do not want to send the victim name or do not record victims in iPass, districts need to select one of the following methods to report victims.

Victims Recorded in iPass – Do Not Want to Report Name to DOE

A parameter has been added to allow districts to choose NOT to report the victim's name associated with a Report to DOE = Yes Discipline Incident. Setting

the parameter of "Report Victim's Name" to = NO will NOT send any name entered into the Additional Victim field and will send only the victim count. <u>Click</u> <u>here for more detail</u>.

• Victims Not Recorded in iPass – Report "Nameless" Victim

If the district chooses NOT to name a victim in the iPass Discipline Incident record, a "nameless victim" must be entered.

First, the user must set the Report Victim's Name parameter to No (see above).

Next, the user will enter one or more student or staff "nameless" victims to the "Other Person" section. <u>Click here for more detail</u>.

iPass Tips & Tricks

Massachusetts State Reporting

EPIMS

After you run the EPIMS Export Report to reset Terms and FTEs, when you go to the Edit EPIMS Work Assignments screen, as long as the Work Assignment records reflect the correct data it does not matter the color of the Work Assignment (purple, peach, or white).

SIF SIMS

If you have a Student who is set to DOE034 = 01 and the data is <u>not</u> updating at the DOE, check the following:

- Is DOE036 (Primary Disability) filled in? This field must remain coded to flag the student to be included in the DOE Special Education Summary data pull to update the DOE034 field.
- Is DOE040 = 02, 08, or 09? If DOE040 = 02, 08, or 09, the student will not be included in the DOE Special Education Summary data pull. Consider changing DOE040 = 03 (Re-evaluation found no longer eligible) for the submission.

SIF SSDR

If you receive the SSDR Error of SSDR2520 – Alt Education indicator field must be Y or N or SSDR6545 – Educational Services code (AE) is required when Education Services Indicator (AEINC) equals Y, check the following:

If you have marked the "Alternate Education Code" = Yes in the **Incident DOE Fields** section



then you must also have the "Alternative Education" = Yes in the **Offender DOE Fields** section.
